It provides a place to enter the date operations cease, indicate where the books and records will be located and provide a contact person. •Section 8. "Branch Withdrawal" - This section will display when the firm is attempting to withdraw a branch that has not had an approved equivalent status. Provides a place to enter the date of withdrawal with a reason for withdrawal and provide a contact person. •Section 9.
