This right will accrue to buyers in the transactions in the above issues. The right will expire on February 12, 2003. In addition, note holders will be asked to elect to receive either Class A or Class C common stock in exchange for their notes. Unless otherwise specified at the time of execution, trades in the above notes should be considered "with rights/election".
