American Homestar Corporation – Common Stock (OTC:HSTRQ)

Notice has been received that the above Company's Third Amended Joint Plan of Reorganization (Plan) filed under Chapter XI of the Federal Bankruptcy Code, became effective on October 3, 2001. Pursuant to the Plan, holders of the above referenced securities *will not* receive any distributions of property on account of their interests.

Members are reminded of their obligations under NASD Conduct Rule 2310 if they continue to engage in transactions in the above security after the effective date.

Members are further advised that deliveries in settlement of contracts in the **OLD** securities, which were executed prior to the announcement that the securities had been deemed worthless, shall be evidenced by either a) the **OLD** security; or b) a *Letter of Indemnity* which shall grant the purchaser any rights and privileges which might accrue to the holders of the physical securities. Such deliveries shall operate to close-out the contract and shall be settled at the existing contract price pursuant to Uniform Practice Code Rule 11530.

Trans-Global Interactive Ltd. – American Depository Receipts (NASDAQ:TGBR)

Effective April 19, 2002, Trans-Global Interactive Ltd. ADRs (TGBR) will effect a 1 for 10 reverse split. Concurrent with the reverse split, the ADR ratio for TGBR will change from 1 ADR representing 10 ordinary shares (1:10) to 1 ADR representing 100 ordinary shares (1:100). Members are advised that there is no corresponding recapitalization of the underlying ordinary shares in the home country of Australia.

The reverse split and ratio change will be effective on the Nasdaq Stock Market, Inc. (Nasdaq) on April 19, 2002, whereby the symbol will change to TGBRD. It is expected that both these actions will result in a price adjustment to TGBRD.
