What is the FINRA Maintaining Qualifications Program (MQP)?
The FINRA MQP permits individuals who have terminated their representative or principal registration(s) to maintain their qualification(s) for up to five years. Participating in the FINRA MQP does not eliminate the two-year qualification termination period. Rather, it provides participants with an alternative means of staying current on their regulatory and securities knowledge for up to five years. The following the termination of their registration(s), by taking continuing education (CE) courses. How does one participate in the FINRA MQP?
To enroil, an individual must sign into their FinPro account, follow the prompts to select the qualification(s) they want to maintain and pay the enrollment fee. To maintain their FINRA MQP participation, an individual must pay the annual fee and complete their assigned annual CE learning plan by the due date specified in FinPro.
What is the cost for participating in the FINRA MQP?
The FINRA MQP has an annual program fee of \$100 regardless of the number of registration categories for which an individual elects to remain qualified.

	NASAA's EVEP provides an opportunity for registered representatives to extend their S63 NASAA qualification exam for a period up to five years by opting into the program, paying an annual fee and maintaining certain continuing education requirements. Registered representatives who opt into NASAA's EVEP can exame the standard two years when not registered with a jurisdiction. 	To participate, an individual must (1) have been registered in the terminated registration category for at least one year immediately prior to the termination of that category. (2) elect to participate within two years from the termination of a registration; (3) must be enrolled and in good standing in the FIRRA MCP. To enroll, an individual must gin in to their FIRPA account, follow the prompts to select the qualification(s) they would like to maintain and pay the enrollment fee. To maintain their NASAA EVEP status, an individual must, on an ammual basis, pay the NASAA EVEP ter and compile the applicable continue document education.
	What is the cost for participating in NASAA's EVEP?
	There is a \$35 annual fee per qualification enrolled in NASAA's EVEP.
