DEFAULT DECISION

May 25, 2017

Respondent (1) failed to report customer complaints to FINRA, (2) failed to amend or timely amend registered representatives' Forms U4, (3) failed to establish and maintain a supervisory system and failed to establish, maintain, and enforce written supervisory procedures reasonably designed to ensure that it reported customer complaints, timely amended its registered representatives' Forms U4 and Forms U5, reviewed email correspondence, and considered plans of heightened supervision for certain registered representatives, and (4) improperly charged hundreds of customers "handling fees." The Firm is fined \$475,000 and ordered to pay restitution to the customers it charged a "handling fee."

DECISION

I. Introduction

On February 1, 2017, FINRA's Department of Enforcement filed a seven-cause Complaint against Respondent Legend Securities, Inc. ("Legend" or the "Firm"). Enforcement alleges that Legend failed to report to FINRA 96 customer complaints and failed to file or timely file amendments to eight registered representatives' Uniform Applications for Securities Industry Registration or Transfer (Form U4) and Uniform Termination Notices for Securities Industry Registration (Form U5). The Complaint further alleges that Legend committed supervision violations by failing to have a reasonable supervisory system and written supervisory procedures (WSPs) to ensure it: reported customer complaints; filed timely amendments to Forms U4 and Forms U5; reviewed incoming and outgoing emails; and considered heightened supervision for brokers with histories of misconduct. It also alleges that Legend impermissibly charged

customers a “handling fee”—as much as \$49.50 for some trades—in more than 34,000 securities transactions, which generated nearly \$900,000 for the Firm. For this misconduct, Enforcement charges Legend with violating NASD Rules 2430, 3010(a), (b), and (d), and 3070(c), FINRA Rules 1122, 2010, and 4530(d), and Article V, Section 2(c) of FINRA’s By-Laws, and willfully violating Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-10 thereunder.

Enforcement served Legend with the Complaint in accordance with FINRA rules. When the Firm did not respond to the Complaint, I held Legend in default. Enforcement then filed a motion for entry of default decision (“Default Motion”). The Firm did not respond to the Default Motion.

For the reasons set forth below, I grant the Default Motion and find that Legend committed each of the violations alleged in the Complaint. I also impose a fine of \$475,000 and order the Firm to pay restitution to customers totaling \$884,436.24.

II. Findings of Fact and Conclusions of Law

A. Legend’s Background

Legend first became a member of FINRA in November 1998. It engaged in a general securities business from its principal place of business in New York, New York. On December 8, 2016, the Firm filed a Uniform Request for Broker-Dealer Withdrawal (Form BDW) seeking to withdraw from registration with FINRA. On January 19, 2017, FINRA cancelled Legend’s registration. On April 17, 2017, FINRA expelled Legend for failure to pay fines and costs.¹

B. Jurisdiction

Although Legend is no longer a FINRA member firm, it remains subject to FINRA’s jurisdiction for purposes of this proceeding under Article IV, Section 6 of FINRA’s By-Laws, because (i) the Complaint charges the Firm with violations committed while it was a FINRA member, and (ii) Enforcement filed the Complaint within two years following the effective date FINRA expelled the Firm.

C. Origin of the Investigation

The Complaint arose from the 2012, 2013, and 2014 cycle examinations of the Firm conducted by FINRA’s Department of Member Regulation. During the investigations, FINRA staff uncovered numerous potential sales practice violations.²

D. Legend Defaulted

On February 1, 2017, Enforcement served the Notice of Complaint and Complaint on Legend at the address recorded in FINRA's Central Registration Depository (CRD), the only address known to Enforcement, by certified mail and first-class mail. Enforcement received a return receipt for the certified mailing signed by a representative of the Firm.³

On March 6, 2017, Enforcement served a Second Notice of Complaint and Complaint on Legend at its CRD address, again by certified mail and first-class mail.⁴

Legend's Answer was due no later than March 23, 2017. Legend did not file an Answer or respond to the Complaint in any manner.⁵

Legend received actual notice of this proceeding. Therefore, Legend's failure to file an Answer to the Complaint constitutes a default. On April 3, 2017, I held Legend in default and ordered Enforcement to file a Default Motion. On May 3, 2017, Enforcement filed the Default Motion. I grant the motion and, pursuant to FINRA Rules 9215(f) and 9269(a)(2), I deem the allegations in the Complaint admitted.

E. Legend Failed to Supervise for Compliance with Customer Complaint Reporting Obligations (Cause One) (Violations of NASD Rules 3010(a) and (b) and FINRA Rule 2010)

Cause one alleges that from April 2011 through December 2014 Legend failed to establish and maintain an adequate supervisory system and WSPs to ensure the identification and timely reporting to FINRA of customer complaints, as required by NASD Rule 3070(c) and FINRA Rule 4530(d).⁶ Enforcement charges that the Firm's failures violated NASD Rules 3010(a) and (b)⁷ and FINRA Rule 2010.

NASD Rule 3010(a) requires each member firm to establish and maintain a system to supervise associated persons, and it details some of the requirements for the design of such a system. NASD Rule 3010(b) requires each member firm to establish, maintain, and enforce written supervisory procedures appropriate to its specific business and that are reasonably designed to achieve compliance with the applicable securities law and regulations, including FINRA Rules.

Legend's written supervisory procedures were deficient in that they failed to set forth the Firm's reporting obligations when it received a customer complaint. According to the Complaint, the Firm's WSPs were limited, requiring it to report only certain disclosures. The Firm's supervisory system did not ensure that associated persons brought customer complaints to supervisory or compliance staff for reporting.⁸ These deficiencies caused the Firm to fail to report, or failed to timely report, customer complaints.

Based on the allegations in cause one, I find that from April 1, 2011, to November 30, 2014, Legend violated NASD Rules 3010(a) and (b) and FINRA Rule 2010.⁹

F. Legend Failed to Report or Late Reported 96 Customer Complaints (Cause Two) (Violations of NASD Rule 3070(c) and FINRA Rules 4530(d) and 2010)

Cause two charges the Firm with failing to report or timely report to FINRA 96 written customer complaints from April 2011 to December 2014, as required by NASD Rule 3070(c) and FINRA Rule 4530(d). The customer complaints alleged multiple sales practice violations, including excessive commissions, churning, unauthorized trading, and misappropriation, among other violations. Twenty-six complaints were never reported to FINRA by the Firm; 29 complaints were reported more than two years after the Firm learned of them; and two complaints were reported nearly three years late. Legend reported most of the complaints only after FINRA staff told the Firm of the deficiency.¹⁰

I find that Legend violated NASD Rule 3070(c) (for conduct before July 1, 2011) and FINRA Rules 4530(d) (for conduct beginning July 1, 2011) and 2010.

G. Legend Failed to Supervise to Ensure Review of Electronic Communications (Cause Three) (Violations of NASD Rules 3010(a), (b), and (d) and FINRA Rule 2010)

Cause three alleges that from April 2011 through December 2014 Legend failed to establish and maintain a reasonable system and WSPs for the review by a registered principal of the Firm's incoming and outgoing electronic, or email, communications, in violation of NASD Rules 3010(a), (b), and (d) and FINRA Rule 2010.¹¹

In addition to the supervisory obligations set forth in NASD Rules 3010(a) and (b), NASD Rule 3010(d)(1) requires a firm to establish procedures to review incoming and outgoing written and electronic communications of its registered representatives relating to the firm's investment banking or securities business. NASD Rule 3010(d)(2) requires a firm to have procedures that are "appropriate to its business, size, structure, and customers for the review" of incoming and outgoing written and electronic communications. FINRA has instructed member firms that the amount of electronic correspondence reviewed "must be reasonable given the circumstances (for example, member size, nature of business, customer base, and individual employee circumstance)."¹²

Legend's WSPs failed to establish the frequency with which the Firm should review electronic communications, the amount of electronic communications required to be reviewed, and the methodology to use to conduct the reviews of electronic communications (for example, identifying search words or type of random review). According to the Complaint, 81 of the customer complaints that constitute the basis for the violations alleged in cause two were sent via email. These complaints contained a word, or words, that the Firm identified in its lexicon or list of words to be searched in emails as part of its review of electronic communications but the Firm failed to identify the specific emails that contained the complaints.¹³ The Firm's procedures accordingly were inadequate to ensure compliance with NASD Rule 3010(d).¹⁴

Based on the allegations of the Complaint, I find that Legend violated NASD Rules 3010(a), (b), and (d) and FINRA Rule 2010 from April 1, 2011 to November 30, 2014.

H. Legend Failed to Reasonably Supervise to Ensure the Filing of Amendments to Forms U4 and Forms U5 (Cause Four) (Violations of NASD Rules 3010(a) and (b) and FINRA Rule 2010)

Cause four alleges that from April 2011 through December 2014 Legend failed to implement adequate supervisory procedures to ensure that it made timely amendments to its registered representatives' Forms U4 and Forms U5. Enforcement charges Legend with violating NASD Rules 3010(a), (b), and (d) and FINRA Rule 2010.¹⁵

The Firm's WSPs, according to the Complaint, obligated the Compliance Department immediately be notified of events that may have required disclosure on a Form U4 or Form U5. These included whether a registered representative is a defendant in a civil, administrative, or arbitration matter, or the subject of any oral or written customer complaint. The WSPs provided that disclosures be made to a Form U4 within 30 days of the event. A 2012 version of the Firm's WSPs required Legend to amend a Form U4 when a registered representative told it of an event requiring disclosure. The procedures required the compliance department to determine if the events were reportable. Legend did not take reasonable steps to ensure that these procedures were enforced. As a result, Enforcement alleges, Legend failed to make timely amendments to Forms U4 and Forms U5.¹⁶

Based on the allegations of the Complaint, I find that Legend violated NASD Rules 3010(a) and (b) and FINRA Rule 2010 from April 1, 2011 to November 30, 2014.¹⁷

I. Legend Failed to File, or Failed to Timely File, Seven Forms U4 (Cause Five) (Violations of Article V, Section 2(c) of FINRA's By-Laws and FINRA Rules 1122 and 2010)

Cause five charges Legend with failing to file, or filing late, seven Forms U4 and one Form U5 on behalf of current and former registered representatives, between April 2011 and December 2014,¹⁸ in violation of Article V, Section 2(c) of FINRA's By-Laws and FINRA Rules 1122 and 2010:

- Two customers filed a single arbitration claim against the Firm and registered representative ES alleging that ES recommended an unsuitable investment in high risk securities. Legend learned of the arbitration by April 12, 2011, but did not update ES's Form U4 until July 14, 2011, more than three months later.

- A customer and a related pension fund filed a FINRA Investor Complaint Form against Legend and registered representatives CT and NV alleging excessive commissions. Legend learned of the complaint no later than October 26, 2011, but did not update CT's Form U4 and NV's (who was no longer employed by Legend) Form U5 until August 17, 2012, more than nine months later.
- A customer asserted a complaint against registered representative DW alleging sales practice violations, including unauthorized trading. Legend learned of the complaint no later than March 22, 2013, but did not update DZ's Form U4 until July 3, 2013, more than three months later.
- A customer filed an arbitration claim against Legend and registered representative MG (and others), alleging churning, unauthorized trading, and unsuitable recommendations. Legend learned of the arbitration by August 9, 2014, but did not amend MG's Form U4 until February 20, 2015, more than six months later.
- A customer complained that registered representative JK engaged in unauthorized trading and misused a margin account. Legend knew of the complaint by October 14, 2014, but never amended JK's Form U4.
- A customer complained that registered representative SK misappropriated money and engaged in unauthorized trading. Legend knew of the complaint by November 7, 2014, but never amended SL's Form U4.
- A customer complained about registered representative JHK, alleging unauthorized trading and misappropriation. The customer later filed an arbitration claim asserting misappropriation, churning, and breach of fiduciary duty. Legend learned of the complaint by December 30, 2014, and learned of the arbitration claim by April 22, 2015, but did not update JHK's Form U4 until September 12, 2016, more than a year later.

Article V, Section 2(c) of FINRA's By-Laws requires member firms to report certain disclosable events on a Form U4 if the registered representative is still employed with the firm. The By-Laws also require that reportable events be reported accurately no later than 30 days after the member firm learns of the facts or circumstances giving rise to the reportable event.¹⁹

FINRA Rule 1122 prohibits a member or person associated with a member from filing information regarding membership or registration "which is incomplete or inaccurate so as to be misleading, or which could in any way tend to mislead, or fail to correct such filing after notice thereof." This provision is intended to ensure that the Forms U4 of registered persons contain accurate, up-to-date information so that regulators, employers, and members of the public "have all material, current information about the securities professional with whom they are dealing."²⁰

Legend failed to correct, or timely correct, its registered representatives' Forms U4 after learning of events that required disclosure on their Forms U4. Filing a misleading Form U4 or failing to file a timely amendment to a Form U4 violates the high standards of commercial honor and just and equitable principles of trade under FINRA Rule 2010.²¹ The Complaint charges that the customer complaints should have been disclosed in response to Questions 14I(1) or 14I(3) on seven registered representatives' Forms U4.²²

Accordingly, I find that Legend violated Article V, Section 2(c) of FINRA's By-Laws²³ and FINRA Rules 1122 and 2010 for failing to file, or failing to timely file, amended Forms U4 in seven instances relating to registered representatives ES, CT, DZ, MG, JK, SK, and JHK.²⁴

J. Legend Failed to Implement a Plan of Heightened Supervision (Cause Six) (Violations of NASD Rules 3010(a) and FINRA Rule 2010)

Cause six alleges that from March 2011 to August 2015 Legend failed to consider whether to impose heightened supervision on 27 registered representatives even though they had histories of customer complaints, disciplinary actions, allegations of misconduct, or had developed records of possible misconduct while associated with the Firm. Enforcement alleges that Legend violated NASD Rule 3010(a) and FINRA Rule 2010.²⁵

The Firm's WSPs in place from 2010 to at least 2014 contained criteria that qualified the 27 registered representatives, because of their employment and customer complaint histories, for consideration for heightened supervision.²⁶ For example, registered representative JC was the

subject of two customer complaints alleging that he engaged in unauthorized trades and made unsuitable recommendations and two state disciplinary actions.²⁷ Registered representative DD consented to FINRA's findings in a Letter of Acceptance Waiver and Consent that he executed trades without written authority.²⁸ Registered representative SM was the subject of three customer complaints while registered with Legend alleging that he made fraudulent misrepresentations, engaged in unauthorized trades, churned accounts, charged excessive commissions, and made unsuitable recommendations.²⁹

FINRA has provided member firms with guidance about when to place registered representatives under heightened supervision.³⁰ Despite ample evidence that the 27 registered representatives should have been placed on heightened supervision, or considered for heightened supervision, as required by the Firm's WSPs, Legend failed to do so.³¹ The Firm also failed to document any consideration it may have given to whether any of the registered representatives should have been placed on heightened supervision or why existing supervision was appropriate.

Based on the allegations of the Complaint, I find that Legend failed to enforce the procedures in its WSPs concerning heightened supervision and thus violated NASD Rule 3010(a) and FINRA Rule 2010 from March 1, 2011 to November 30, 2014.

K. Legend Improperly Charged Customers "Handling Fees" for Securities Transactions (Cause Seven) (Violations of Section 10(b) of the Securities Exchange Act of 1934, Rule 10b-10, NASD Rule 2430, and FINRA Rule 2010)

Cause seven alleges that Legend charged customers an unlawful "handling fee" of up to \$49.50 in 34,313 securities transactions from January 1, 2013, to May 31, 2014. Legend imposed the "handling fee" in addition to a commission or a markup/markdown. Over 16,000 transactions contained a "handling fee" of \$40.00 or more; 20,000 transactions had a "handling fee" of \$10.00 or more.³² Legend generated \$884,436.24 in revenue from the fees.³³ Enforcement alleges that this conduct violated Section 10(b) of the Exchange Act, Rule 10b-10, NASD Rule 2430, and FINRA Rule 2010.

Exchange Act Rule 10b-10 requires broker-dealers to disclose certain information in writing to customers at or before completion of a transaction. Specifically, Rules 10b-10(a)(2)(i)(B) and (D) require broker-dealers to disclose “the amount of any remuneration received or to be received by the broker from such customer in connection with the transaction,” and the “source and amount of any other remuneration received or to be received by the broker in connection with the transaction.” NASD Rule 2430 provides that “[c]harges, if any, for services performed, including miscellaneous services such as collection of moneys due for ... exchange or transfer of securities ... shall be reasonable and not unfairly discriminatory between customers.”³⁴

The Complaint alleges that Legend inaccurately described the charges on customer trade confirmations as “handling fees,” “depicting them as a distinct fee, separate and apart from any commission or mark[up]/markdown.” The Firm, according to the Complaint, did not provide any specific services or incur costs or expenses in connection with processing the transaction associated with the corresponding confirmation. According to Enforcement, Legend applied all of the revenues from the “handling fees” to the general, ongoing costs of operating the Firm. By describing the charges as “handling fees,” Legend understated the total commission amount it charged its customers. The confirmations were therefor misleading and inaccurate, according to the Complaint.³⁵

Legend failed to ensure that its confirmations adequately disclosed the Firm’s remuneration to customers.³⁶ Disclosures in confirmations are intended “to protect investors and combat broker-dealer fraud by ensuring full and fair disclosure to investors”³⁷ Legend failed to deal fairly with its customers, causing them considerable financial harm.³⁸ The Firm recklessly overcharged hundreds of customers improper fees.

I find that Legend violated Section 10(b) of the Exchange Act and Exchange Act Rule 10b-10 by providing customers with misleading information about the remuneration it received from executing securities transaction. I find that Legend also violated NASD Rule 2430 because the “handling fees” it charged customers for executing the transactions were not connected to

any services performed and accordingly were not reasonable.³⁹ The Firm's misconduct also constitutes a violation of FINRA Rule 2010.

III. Sanctions

In determining the appropriate sanctions, I considered FINRA's Sanction Guidelines ("Guidelines").⁴⁰ The Guidelines contain nine "General Principles" and 19 "Principal Considerations" that apply to all violations, and additional guidelines tailored to specific violations. Two of the General Principles are applicable here. General Principle No. 1 states that "sanctions should be designed to protect the investing public by deterring misconduct and upholding high standards of business conduct." Sanctions should "reflect the seriousness of the misconduct at issue."⁴¹ General Principle No. 3 instructs adjudicators to "tailor sanctions to respond to the misconduct at issue," so that the sanctions imposed "address the misconduct involved in each particular case."⁴²

After evaluating the allegations in the Complaint, Enforcement's arguments in the Default Motion, and the supporting Declaration, I impose the following sanctions.

A. Supervision (Causes One, Three, Four and Six)

Causes one, three, four, and six charge Legend with violating NASD Rules 3010(a), (b), and (d) by failing to exercise reasonable supervision and maintain adequate WSPs to ensure: the reporting of customer complaints to FINRA; review of email communications; filing of amendments to Forms U4 and Forms U5; and considering whether to place registered representatives on heightened supervision. Because the Firm's various supervisory deficiencies involve similar misconduct, I impose a unitary sanction for these violations consisting of a \$175,000 fine.⁴³

The Guideline for failing to supervise instructs adjudicators to consider a fine of \$5,000 to \$73,000 and limit the activities of the appropriate branch office or department for up to 30 business days. In egregious cases, it may be appropriate to limit a firm's activities for a longer period. The relevant principal considerations are whether the respondent ignored "red flag" warnings that should have resulted in additional supervisory scrutiny and the nature, extent, size, and character of the underlying misconduct.⁴⁴ The Guideline for maintaining deficient WSPs provides for a fine between \$1,000 and \$37,000. In egregious cases, an adjudicator should consider suspending the firm with respect to any or all activities or functions for up to 30 business days and thereafter until the WSPs are amended to conform to rule requirements. The principal considerations are whether the deficiencies allowed the violative conduct to occur or escape detection and whether the deficiencies made it difficult to determine the individuals responsible for specific areas of supervision or compliance.⁴⁵

In the case of systemic supervisory failures,⁴⁶ the Guidelines suggest a fine between \$10,000 and \$292,000. Where aggravating factors predominate, a higher fine should be considered.⁴⁷ The most relevant principal considerations in determining sanctions where systemic supervisory failures exist are whether the deficiencies allowed violative conduct to occur or to escape detection, the number and type of customers, investors or market participants affected by the deficiencies, and the nature, extent, size, character, and complexity of the activities or functions not adequately supervised as a result of the deficiencies.

I find that the supervisory failures in this case were systemic and egregious. Legend displayed a complete indifference to its supervisory obligations thereby generating a culture of noncompliance with FINRA rules and SEC regulations at the Firm. The underlying misconduct that was not held in check by appropriate supervision included potentially serious sales practice violations that had a high probability of causing harm to customers. Without implementing, or considering whether to implement, a plan of heightened supervision, the Firm may have allowed its registered representatives to operate without boundaries. Failing to report, or timely report, customer complaints prevented or delayed investigations by FINRA and signaled to the Firm's registered representatives that no one would scrutinize their activities.

After weighing all the circumstances present in this case, including the fact that supervisory failings persisted for over three years, I find that an appropriate sanction is a \$175,000 fine.

B. Failure to Report to FINRA Customer Complaints (Cause Two)

Legend never reported 26 customer complaints and reported 70 complaints late, in violation of NASD Rule 3070(c) and FINRA Rule 4530(d). The Guidelines for failing to report customer complaints instruct an adjudicator to consider a fine between \$5,000 and \$146,000. In egregious cases, consideration should be given to suspending the firm with respect to any or all activities or functions until the firm corrects the deficiency. For late reporting customer complaints, the Guidelines suggest a fine between \$5,000 and \$73,000.⁴⁸ The principal considerations for not reporting or late reporting complaints are the same: (i) whether the events not reported or late reported would have established a pattern of potential misconduct, and (ii) the number and types of incidents not reported or late reported.⁴⁹

The Firm never reported 26 customer complaints and reported 70 complaints late over a period of nearly four years. Many of the customers' complaints charged brokers with serious sales practice violations, including ten complaints alleging churning, 20 alleging unauthorized trading, and three alleging misappropriation.⁵⁰ These serious claims likely would have triggered FINRA investigations that could have prevented or limited harm to other customers. The information reported by members about customer complaints "provides [FINRA] with important regulatory information that assists with the timely identification of problem members, branch offices, and registered representatives to detect and investigate potential sales practice violations."⁵¹

I find that the Firm's failure to report and late reporting 96 complaints is egregious. Accordingly, an appropriate and remedial sanction is a \$75,000 fine.

C. Failure to File or Timely File Amendments to Forms U4 (Cause Five)

For failing to file, or filing late, or filing false, misleading, or inaccurate Forms U4 or amendments, the Guidelines recommend fining a firm between \$5,000 and \$73,000. Where aggravating factors predominate, an adjudicator should consider imposing a higher fine and suspending the firm with respect to any or all relevant activities or functions until the firm corrects the deficiency.⁵²

The most relevant principal considerations include (i) the nature and significance of the missing information at issue; (ii) the number, nature, and dollar value of the disclosable events at

issue; (iii) whether the omission of information was done intentionally to conceal information; and (iv) the duration of the delinquency.⁵³ The missing information included serious allegations involving customer-related sales practice violations. In two instances, the Firm never filed amended Forms U4. In five other instances, the registered representatives' Forms U4 were not amended until between three months and one year after the Firm became aware of the disclosable event.

Given the limited number of violations, I do not find that aggravating factors predominate. After applying the principal considerations, I find that the appropriate and remedial sanction for failing to file, or failing to timely file, amendments to Forms U4 in seven instances is a \$25,000 fine.

D. Misleading Customer Confirmations and Charging “Handling Fees” (Cause Seven)

The Guidelines provide for a fine of between \$1,000 and \$7,000 for a first action involving failures to comply with Exchange Act Rule 10b-10. Principal considerations are the nature and materiality of the inaccurate or misleading information and the number of affected confirmations. Adjudicators are instructed to consider suspending a firm with respect to any or all activities or functions for up to 30 business days. In egregious cases, adjudicators should consider a suspension of up to two years or an expulsion.⁵⁴

There are no Guidelines for violations of NASD Rule 2430 or its replacement, FINRA Rule 2122. An analogous guideline is the one for excessive markups/downs and excessive commissions for violations of FINRA Rules 2121, 2121.01, and 2121.02. In the case of a first action, the Guidelines instruct an adjudicator to consider a fine between \$5,000 and \$73,000, and (where restitution is not ordered) adding the gross amount of the excessive markups, markdowns, or commissions. For negligent misconduct, an adjudicator should consider requiring corrective action with respect to a firm's markup/markdown policy or commission policy. In the case of intentional or reckless misconduct, an adjudicator should consider suspending a firm's activities with respect to any or all relevant activities or functions for between 10 business days and two years. Where aggravating factors predominate, consideration should be given to expelling the firm. The relevant principal consideration is the number of harmed customers and the quantified customer harm.⁵⁵

Because violations of Rule 10b-10 facilitated charging improper “handling fees” in violation of NASD Rule 2430, I find that the underlying misconduct is related and accordingly impose a unitary fine.

I find that Legend's misconduct was egregious after considering that hundreds of customers⁵⁶ were affected and the harm caused by the impermissible "handling fees" totaled \$884,436.24. While many customers suffered damages totaling less \$100, at least 200 customers were charged more than \$1,000 in "handling fees." Three customers paid over \$10,000.⁵⁷ An appropriate and remedial fine should exceed the range for a first action for violating Rule 10b-10 and charging improper fees. Accordingly, I impose a fine of \$200,000, which is nearly three times the high end of recommended fine range for a first action for charging excessive markups/downs and commission.

I also order restitution. The Guidelines instruct adjudicators to order restitution where it is appropriate to remediate misconduct and necessary to "restore the status quo ante where a victim otherwise would unjustly suffer loss."⁵⁸ Restitution may be ordered when an identifiable person has suffered a quantifiable loss proximately caused by a respondent's misconduct. I conclude that the customer losses were the direct and proximate result of Legend's misconduct. Enforcement used Legend's trade blotters to calculate the amount of "handling fees," which I find sufficiently precise and complete.⁵⁹ Accordingly, Legend shall pay \$884,436.24 in restitution to the customers identified in the addendum attached to this Decision, plus interest at the rate established for the underpayment of taxes in Section 6621(a) of the Internal Revenue Code, from January 1, 2013, until paid.⁶⁰

In the event that the customers cannot be located, unpaid restitution plus accrued interest should be paid to the appropriate escheat, unclaimed-property, or abandoned-property fund for the respective state of each customer's last known address. Satisfactory proof of payment of the restitution, or of reasonable and documented efforts undertaken to effect restitution, shall be provided to the staff of FINRA's Department of Enforcement no later than 90 days after the date when this decision becomes final. The customers are identified by name in an addendum to this decision, which is served only on the parties.

IV. Order

Respondent Legend Securities, Inc., failed to have a reasonable supervisory system and written supervisory procedures (WSPs) to ensure it timely reported customer complaints, filed timely amendments to Forms U4 and Forms U5, reviewed incoming and outgoing email communications, and considered heightened supervision for brokers with histories of misconduct, as alleged in causes one, three, four and six. The Firm violated NASD Rules 3010(a), (b), and (d) and FINRA Rule 2010. It is fined \$175,000 for the supervision-related violations.

As alleged in cause two, Legend failed to report, or late reported, 96 customer complaints to FINRA, in violation of NASD Rule 3070 and FINRA Rules 4530 and 2010. The Firm is fined \$75,000.

As alleged in cause five, Legend failed to file and timely file amendments to Forms U4 for seven of its registered representatives, in violation of Article V, Section 2 of FINRA's By-Laws and FINRA Rules 1122 and 2010. It is fined \$25,000 for this misconduct.

Finally, as alleged in cause seven, the Firm improperly charged customers "handling fees" in 34,313 securities transactions. The confirmations sent to customers described the charges as "handling fees," which was misleading and inaccurate. The Firm willfully violated Section 10(b) of the Securities Exchange Act of 1934, Exchange Act Rule 10b-10, and violated NASD Rule 2430 and FINRA Rule 2010. The Firm is fined \$200,000 and ordered to pay restitution totaling \$884,436.24, plus interest.

The total fine of \$475,000 shall be due on a date set by FINRA, but not sooner than 30 days after this decision becomes FINRA's final disciplinary action in this proceeding.
