#### Introduction

As announced in Regulatory Notice 14-07, on January 17, 2014, the SEC approved a proposed rule change to (i) adopt FINRA Rule 4552 to require each ATS to report to FINRA weekly volume information and number of securities transactions within the ATS (ATS reporting requirement); and (ii) amend FINRA Rules 6160, 6170, 6480 and 6720 to require each ATS to acquire and use a single, unique MPID when reporting information to FINRA (MPID requirement). As part of these new requirements, FINRA will make the reported volume and trade count information for equity securities publicly available on its website and available for download on a subscription basis.

FINRA will publish on its website the reported information in each equity security for each ATS for each week. Initially, FINRA will publish the aggregate reported information regarding NMS stocks in Tier 1 of the NMS Plan to Address Extraordinary Market Volatility on a two-week delayed basis. FINRA will publish the information on all other NMS stocks and OTC Equity Securities subject to FINRA trade reporting requirements on a four-week delayed basis. All reports will be available for download directly from the website or via automation described below on a subscription basis.

#### **Automation of Download**

The ATS Transparency file download process may be automated by firms with a current subscription using the following instructions.

#### Requirements:

- 1. EWS/ATS User Account
  - a. New users should refer to the FINRA Entitlement Program information.

#### Machine-download Instructions:

- Go to the machine download page at: https://ats.finra.org/TradingDetailFileArchive/TradingDetailFilesDownloadGrid
- 2. If not already logged in, you will be redirected by EWS to their login page where you will:
  - a. Input your ATS username in the "user" input field.
  - b. Input your security answer in the "ans0" input field,
  - c. And input your password in the "password" input field.
- 3. Once on the download page, parse through the "tblTrading" HTML table.

Note: Parsing through the ATS data tables may be a different process depending on the application or methodology used. The code developed to parse the table will be determined by each individual firm and will not be dictated or directed by FINRA.

### File Availability

Files will be available to professional subscribers via download. Weekly files and updates to previously published files will be published and available for download no earlier than 6:00 AM E.T. on business days.

Users may attempt to access the files on non-business days; however, due to server maintenance which occurs on weekends and other non-business days it is possible that the user will not have immediate success in accessing the data during these days.
