#### 1 ATS Reporting File Format Specification

The Alternative Trading System (ATS) Reporting File Format Specification provides firms with information needed to prepare, format and submit Trade Report files to FINRA as well as receive the response file from FINRA.

#### 1.1 File Submission Location and Timing

Files should be submitted to FINRA using the secure SFTP Protocol as a complete file for each submission. Firms must be authorized within the FINRA Entitlement Program prior to submitting files.

Firms will be required to drop their files on hostname; filetransfer.finra.org. An "ats/in" directory will be made available where Firms will place files.

Firms will be required to submit their files no later than 5:00 p.m. Eastern Time seven business days following the end of the calendar week for which reports are being submitted.

#### 1.2 File Formatting Rules

Several records may be combined into a single file, and must be assembled in the prescribed sequence: <heater>< trade report records><trailer>. The header record is required to be the first record, and the trailer record is required to be the last record. The rest of the records may be included in any order.

The following rules apply to the formatting of the files:

- 1. Each file must contain a header record as the first record.
- 2. Each file must contain a trailer record as the last record.
- 3. Failure to pass validation on the header or trailer values will result in rejection of the entire file.
- 4. Trade report records within the file may be in any sequence.
  - a. If no volume is reportable a file with a Header and Trailer must be submitted.

#### 1.3 File Preparation

Each file submitted to FINRA must have a unique filename and must contain the Trade Report Start Date and File Type. The Trade Report Start Date and File Type must match what is in the Header. The file naming convention to be used is:

<FINRA Assigned ATS Identifier>\_<YYYY-MM-DD>\_<File Type>.txt

For example: ATSI\_2013-10-08\_EQ.txt ATSI\_2013-10-08\_FI.txt

#### 1.4 Delimited Format

The ATS Trade Report File must be submitted in pipe delimited text format (decimal 124; ASCII |).

- The delimiter marks the end of the current field and the beginning of the next field.
- Each field is identified by its relative position within each record.
- The sequence of the fields within each record must be exactly as stated in the record layouts that follow.
- Fields may be zero length.
- Fields may not have leading zeros, commas or decimals.
- Fields may only contain ASCII characters in the range of decimal 32 to decimal 126, inclusive, and excluding decimal 124 (the pipe character itself).

Additionally, each line must be terminated using the same method; either a carriage return (decimal13; ASCII CR) or a carriage return followed by a linefeed (decimal13,10; ASCII CR,LF)

#### 1.5 File Requirements

This section discusses certain file requirements for your reference.

- 1. An ATS is required to submit a file to FINRA even when there is no activity for a given trading week. In this case the file will contain only a Header and Trailer.
- 2. FINRA will return a Response file in all cases for each file an ATS submits even when there are no rejects. In this case the file will contain only a Header and Trailer.
- 3. A Response file from FINRA may contain rejected records for an individual file.
- 4. An ATS will be required to resubmit corrected records returned in the Response file as rejects from FINRA. The corrected records must be part of a new, complete file for the trading week. Delta files are not supported.
- 5. Revisions and corrections of previously reported aggregates must be part of a new, complete file for the trading week. Delta files are not supported.
  - a. In order to correct a previously reported aggregate for a security a new file shall be sent containing the revised value(s) in Total Shares and/or Total Trades field(s) for the security.
  - b. In the event As-of Corrections or Reversals are reported, a file must be sent to FINRA that reflect the revised aggregate Total Shares and Total Trades for that Security.
- 6. In the event multiple complete files are received for a single week FINRA will use the last record received for each security based on the file receive timestamp by FINRA.
- 7. Test securities must be excluded from the file.
- 8. Duplicate row(s) for a specific security and trade date combination will be rejected.
- 9. Equity security symbols submitted must be in the following format;
  - a. For OATS reportable issues, please use OATS symbology.
  - b. For all other issues, please use the FINRA daily list symbology.
- 10. Fixed Income security symbols submitted must be in the following format;
  - a. TRACE security master symbol provided by FINRA.
- 11. The Trade Report Start Date is always Monday. The file includes trade reports for execution dates occurring Monday Sunday.
  - a. In the event a trade occurs on a US holiday or a weekend, trades for those trade dates should be included in the file.

#### 1.6.3 FINRA Response File Format

FINRA will process the files submitted by firms in the order the files were received. A response file will be generated by FINRA for each file received and processed. A response may contain only a Header and Trailer which reflects no rejects for a file.

In the event of Header or Trailer mismatches, the response file will contain a single reject record.

The same format will be used for Equity and Fixed Income files. The File Type field in the header will differentiate Equity versus Fixed Income.

Each file generated by FINRA will have a unique filename and must contain the Trade Report Start Date and File Type as submitted in the file. The file naming convention FINRA will use is:

<FINRA Assigned ATS Identifier>\_<YYYY-MM-DD>\_<File Type>\_Response.txt

For example:

ATSI\_2013-10-08\_EQ\_Response.txt ATSI\_2013-10-08\_FI\_Response.txt

### 1.6.3.1 FINRA Response File Location and Timing

Firms will be required to pick up their response file(s) on hostname; filetransfer.finra.org. An "ats/out" directory will be made available where Firms will place files.

Response files will be generated by FINRA and made available for Firms to pick up by 6:00 a.m. E.S.T on the following business day.

### 1.8 Reject Descriptions

A description of the reject reason will be provided back to the user for each record that fails validation. In the event there is a Header or Footer mismatch the entire file will reject. A maximum of 25 characters will be utilized for the reason describing the FINRA reject.

A file or record may be rejected for the following reasons;

Reject Reason	Description
EMPTY-FILE	Zero length file
BAD-VALUE	Unparseable value or value out of range
BAD-FIELD-COUNT	Field count contains incorrect number of fields for row
BAD-ROW-COUNT	Footer contains a different number of rows than were actually found
NO-FOOTER	Missing footer
BAD-SYMBOL	Symbol not found
BAD-CUSIP	CUSIP/CINS not found
BAD-ATS-IDENTIFIER	Primary MPID and FINRA Assigned ATS Identifier combination are invalid
DATE-OUT-OF-RANGE	Trade Date is not within week specified by Trade Report Start Date
DUPLICATE	Duplicate row found

#### 1.9 Security Symbol Supplement and Resource Guide

This section serves as a supplemental resource for security and symbol information provided by FINRA. The use of symbols for the ATS Trade Reporting File Specification and User Guide are required as outlined below.

- 1. Equity security symbols submitted must be in the following format;
  - a. For OATS reportable issues, please use OATS symbology.
  - b. For all other issues, please use the FINRA daily list symbology.
- 2. Fixed Income security symbols submitted must be in the following format;
  - a. TRACE security master symbol provided by FINRA.

All NMS securities are OATS reportable. OTCBB and Other-OTC securities may or may not be OATS reportable. TRACE securities are not OATS reportable. The following pages provide direct links to webpages and files.

**Note:** The suffix field in the file submitted to FINRA shall only be used for CQS securities.

#### **OATS Reportable Securities**

Use the OATS symbol format to submit a security symbol as part of the file submission to FINRA. FINRA publishes an OATS reportable securities list daily. Links to the webpage and start of day and end of day files are below;

#### **All Other Securities**

Use the FINRA daily list symbol format to submit a security symbol as part of the file submission to FINRA.
