## 1 Introduction

Web EFT is a system provided by FINRA that replaces the CRD Electronic File Transfer system with a web based document transfer system that will transfer information across the Internet in the form of uploads and downloads to and from external users. It will offer users the ability to upload batch data to FINRA, either automatically without user-intervention, or interactively by logging-in to a website. Web EFT will also post reports containing the results of the processing.

This document provides details on the format of the data being sent and the form processing requirements.

## 2 Secure Gateway Schemas

W3C schemas are used to describe and constrain the definition of transaction batches that are sent to FINRA.

### 2.1 Common Complex Types

The complex types are divided into 2 types, input and result.

The input complex types are NSGBatch and NSGRequest. Both of these types are required of all files, which are transmitted to the FSG.

A third type that is required for input files is also identified in the CRDFormFiling Schemas section. This section identifies the types of forms that are filed and namespace information. CRDFormFiling is nested once inside of each NSGRequest type.

The result complex types are NSGBatchResults, NSGResult, NSGErrors and NSGError.

#### 2.1.1 NSGBatch

NSGBatch is the main envelope wrapper for the file and is required for all incoming files. The NSGBatch node may contain from 1 to 5000 NSGRequest types.

The required UserBatchRef attribute is a user definable string that must be unique to each submitted batch. The user can also use the string track batches for internal purposes.

The user may specify an email address for which the system is to communicate back status information.

### 2.1.2 NSGRequest

NSGRequest is the wrapper for a requested application transaction.

The user is required to specify the application to which the transaction to be processed by and the user may add a transaction reference identifier to help in their internal tracking. Currently, the only Application identifier that is supported is CRDFF, used to submit CRD form requests.

The NSGBatchResults node is the root node for the set of Results that are returned to the user for a requested NSGBatch. The NSGBatchResults will contain either 1 or more instances of the NSGResult or NSGErrors types, but not both.

## 2.2.3 Form Filing Errors

The following is a list of possible error codes and descriptions that can be expected based on a failure to pass form filing completeness checks. Completeness Checks (CC) errors must be corrected prior to submitting the filing. Informational Messages (IM) will not prevent user from submitting the filing. Form filings must pass SCHEMA validation in order for the system to process the filing.

## 3 CRD U4 U5 and NRF Form Filing Schemas

W3C schemas are used to describe and constrain the definition of electronic CRD Form Filing requests. Schemas definitions for all CRD forms follow a common structure. A top-level schema is defined for each CRD Form. To promote readability and reuse, all top-level schemas reference a set of pre-defined complex types. A separate 'sub' schema exists for each reusable complex type. The inclusion of a set of sub-schemas into each top-level schema is accomplished through a single import directive.

### 3.1 CRD Form Filing

CRDFormFiling is the wrapper for an Individual form filing transaction. CRDFormFiling is a complex type used to represent form-filing requests for U4, U5 and NRF. There is a one-to-one relationship between the NSGRequest and CRDFormFiling.
