### 1. Text of Proposed Rule Change

- (a) Pursuant to the provisions of Section 19(b)(3) of the Securities Exchange Act of 1934 ("Act"), <sup>1</sup> the National Association of Securities Dealers, Inc. ("NASD") is filing with the Securities and Exchange Commission ("SEC" or "Commission") a proposed rule change to delay until no later than November 30, 2005 the implementation date of the recent revisions to the Limited Principal Registered Options (Series 4) examination program. NASD is not proposing any textual changes to the By-Laws, Schedules to the By-Laws, or Rules of NASD.

### 2. Procedures of the Self-Regulatory Organization

At its meeting on January 24, 2001, the Board of Directors of NASD Regulation, Inc. authorized the staff to propose modifications to examination programs, including study outlines, examination specifications, and question banks, and to file the proposed modifications with the Commission, without obtaining further or specific authorization from the Board of Directors of NASD Regulation, Inc. The Board of Governors of NASD had an opportunity to review that action at its meeting on January 25, 2001. Further, counsel for The Nasdaq Stock Market, Inc. and NASD Dispute Resolution, Inc. were provided an opportunity to consult with respect to that action. No other action by NASD is necessary for the filing of the proposed rule change.

As further discussed below, NASD is filing the proposed rule change for immediate effectiveness. NASD proposes to implement the Series 4 examination

program revisions by no later than November 30, 2005. NASD will announce the revisions to the Series 4 examination program and the implementation date in a Notice to Members to be published no later than October 31, 2005.

# 3. <u>Self-Regulatory Organization's Statement of the Purpose of, and Statutory</u> <u>Basis for, the Proposed Rule Change</u>

### (a) Purpose

On February 9, 2005, NASD filed with the SEC for immediate effectiveness revisions to the Series 4 examination program.<sup>2</sup> The Series 4 examination program is an industry-wide examination that qualifies an individual to function as a Registered Options Principal. The examination is shared by NASD and the following SROs: the American Stock Exchange LLC ("Amex"), the Chicago Board Options Exchange, Incorporated, the New York Stock Exchange, Inc., the Pacific Exchange, Inc. ("PCX"), and the Philadelphia Stock Exchange, Inc. The Amex and PCX filed with the SEC similar revisions to the Series 4 examination program.<sup>3</sup> NASD originally had proposed to implement the Series 4 examination program revisions by no later than April 29, 2005. However, due to administrative issues, NASD is proposing to delay until no later than November 30, 2005 the implementation date of the revisions. NASD will announce the revisions to the Series 4 examination program and the implementation date in a Notice to Members to be published no later than October 31, 2005.

NASD understands that the Amex and PCX also will file with the SEC similar proposed rule changes to delay until no later than November 30, 2005 the implementation date of the revisions to the Series 4 examination program.
