Partial Amendment

If the self-regulatory organization is amending only part of the text of a lengthy proposed rule change, it may, with the Commission's permission, file only those portions of the text of the proposed rule change in which changes are being made if the filing (i.e. partial amendment) is clearly understandable on its face. Such partial amendment shall be clearly identified and marked to show deletions and additions.

On July 22, 2005, NASD filed SR-NASD-2005-094 to amend Rule 10308 of the NASD Code of Arbitration Procedure relating to the classification of arbitrators. NASD is filing this partial Amendment No. 1 to make the following changes to the rule filing:

1. On pages 3 and 13 of the original rule filing, please delete the text of proposed Rule 10308(a)(4)(A)(i) that reads “associated with or registered through a broker or a dealer” and replace it with “associated with, including registered through, a broker or a dealer”.
2. Please amend the second paragraph on page 6 of the original rule filing as follows (new language is underlined, deletions are in brackets):

NASD will announce the effective date of the proposed rule change in a Notice to Members to be published no later than 30 [60] days following Commission approval. The effective date will be no later than 60 [30] days following publication of the Notice to Members announcing Commission approval.²

3. On pages 10 and 18 of the original rule filing, please add the following footnote at the end of the last paragraph of the Purpose section:

For purposes of Rule 10308(a)(4)(A)(i), the term “including” is expanding or illustrative, not exclusive or limiting. The use of the term “including but not limited to” in Rule 10321(d) of the Code is not intended to create a negative implication regarding the use of “including” without the term “but not limited to” in Rule 10308(a)(4)(A)(i) or other provisions of the Code.

² If an arbitrator’s classification changes solely because of an amendment to the definitions in Rule 10308, the arbitrator’s classification will be changed prospectively, that is, for future appointments only. In ongoing cases, staff will notify the parties of the prospective change in the arbitrator’s classification. In such situations, because the arbitrator’s classification was correct when the arbitrator was appointed, NASD normally will not grant challenges for cause based on a prospective change in classification. This provides continuity and avoids unnecessary disruption to ongoing cases. Challenges for cause still may be made based upon the disqualification and removal criteria in Rules 10308(d) and 10312(d).
