On April 20, 2006, the National Association of Securities Dealers, Inc. ("NASD") filed with the Securities and Exchange Commission ("Commission") proposed rule change SR-NASD-2006-052 for immediate effectiveness. The proposed rule change extends the effective date for the recent amendments to NASD's Order Audit Trail System rules until July 10, 2006.

NASD is filing with the Commission this Partial Amendment No. 1 to SR-NASD-2006-052 ("Partial Amendment No. 1") to make certain technical changes to the proposed rule text of Rule 6957(c), among other clarifying changes. NASD is also including with this Partial Amendment No. 1: (1) Exhibit 4 (see below), which reflects changes to the text of the proposed rule change, marked to show additions to and deletions from the text as proposed on April 20, 2006; and (2) Exhibit 5 (see below), which reflects the proposed changes to rule text in SR-NASD-2006-052, including the proposed changes to the rule text in this Partial Amendment No.1.

Specifically, NASD is filing this Partial Amendment No. 1 to make the following changes:

On pages 3 of SR-NASD-2006-052, please replace footnote 4 to read as follows:

The proposed changes indicated below are based on rule text approved by the SEC on September 28, 2005 and March 30, 2006, which, but for this subsequent filing, would have become effective May 8, 2006. See supra notes 2 and 3.

On pages 10 of SR-NASD-2006-052, please replace footnote 7 to read as follows:

The proposed changes indicated below are based on rule text approved by the SEC on September 28, 2005 and March 30, 2006, which, but for this subsequent filing, would have become effective May 8, 2006. See supra notes 5 and 6.

On pages 4 and 10 of SR-NASD-2006-052, please replace the text of the proposed rule language in Rule 6957(c), which is on page 4 and spans pages 10-11, respectively, to read as follows:

The requirements of the Order Audit Trail System shall be effective on July 10, 2006[six months after publication of the revised *OATS Reporting Technical Specifications* relating to SR-NASD-00-23,] for all manual orders, provided that firms shall be required to report information item (18) specified in Rule 6954(b) only to the extent such item is available to them.
