Notice has been received that the above Company's Joint Plan of Reorganization (Plan) filed under Chapter XI of the Federal Bankruptcy Code, became effective on May 21, 2002. Pursuant to the Plan, On the Effective Date, the Convertible Subordinated Note Indenture and all Cancelled Securities shall be cancelled and, except for purposes of distribution under the Plan, all obligations thereunder discharged by confirmation of this Plan. The Holders of Allowed Interests in USi and/or Allowed LLC Interests shall receive no distribution under this Plan.

Members are reminded of their obligations under NASD Conduct Rule 2310 if they continue to engage in transactions in the above security after the effective date.

Members are further advised that deliveries in settlement of contracts in the OLD securities, which were executed prior to the announcement that the securities had been deemed worthless, shall be evidenced by either a) the OLD security; or b) a Letter of Indemnity which shall grant the purchaser any rights and privileges which might accrue to the holders of the physical securities. Such deliveries shall operate to close-out the contract and shall be settled at the existing contract price pursuant to Uniform Practice Code Rule 11530.
