AWARD: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Claimant's claims against Respondents Layne, Atkins, and Crosswell are dismissed in their entirety. 2) Respondents Fletcher, Mitchell, and Palmer are jointly and severally liable and shall pay to the claimant \$24,481.00. 3) Respondents Fletcher, Mitchell, and Palmer are jointly and severally liable and shall pay claimant interest at a rate of 8% per annum from May 26, 2000 until the date that the award is paid. Interest is calculated on \$8,481.00 only. 4) All other relief requests are denied. 5) The \$425.00 filing fee previously deposited with NASD Dispute Resolution, Inc. by the claimant, shall be retained by NASD Dispute Resolution, Inc. 6) Respondents Fletcher, Mitchell, and Palmer are jointly and severally liable and shall pay claimant \$425.00 as reimbursement of the filing fee.
