CASE SUMMARY

Claimant Donald Onofrey asserted the following causes of action: Misrepresentation, Omission, Churning, Unsuitability, Negligence, Negligent Supervision, and Fraud.

The causes of action relate to the management of Claimant's account with Leader Investment.

Unless specifically admitted in their Answer, Respondents denied the allegations made in the Statement of Claim and asserted the following defenses: Ratification, Waiver, Estoppel, and Laches.

OTHER ISSUES CONSIDERED AND DECIDED

On November 02, 2001, Respondents filed a Motion for Change of Venue on Grounds of Forum Non Conveniens. Claimants filed a Response on November 08, 2001. On December 05, 2001, the panel granted the Motion and the case was transferred from Indianapolis, Indiana to Chicago, Illinois.

The panel agrees that this was an egregious case of misfeasance and/or malfeasance on the part of Respondent Harry Cavallaris and, by extension, Respondent Leader Investment, Inc. in mishandling Claimant Donald Onofrey's account and failing to supervise such mishandling. Claimant Onofrey, however, has an obligation to monitor his account, which he failed to do, later claiming ignorance of the losses and unauthorized trades.

AWARD

After considering the pleadings, the testimony and evidence presented at the hearing, and the post-hearing submissions, the Panel has decided in full and final resolution of the issues submitted for determination as follows:

1. Respondents Leader Investment, Inc. and Harry Cavallaris are jointly and severally liable to and shall pay Claimant Donald Onofrey losses in trades the amount of \$1.00 (one dollar).
2. In addition, Respondents Leader Investment, Inc. and Harry Cavallaris are jointly and severally liable to and shall pay Claimant Donald Onofrey the amount of \$49,868.00 (forty-nine thousand eight hundred sixty-eight dollars) for all commissions paid by Claimant Donald Onofrey for Leader Investment, Inc. trades

and all margin-account interest paid for Leader Investment, Inc. trades. This figure represents the total amount of commissions paid totaling \$58,736.00 less the amount Claimant Donald Onofrey has or will receive from the NASD as repayment for said commissions in the amount of \$8,868.00.

3. Respondents Leader Investment, Inc. and Harry Cavallaris are jointly and severally liable and shall to Claimant Donald Onofrey the amount of \$4,459 ("four thousand four hundred fifty nine dollars) as costs.
4. Respondents Leader Investment, Inc. and Harry Cavallaris are jointly and severally liable to and shall pay Claimant Donald Onofrey the amount of \$42,250.00 (forty-two thousand two hundred fifty dollars) as attorney's fees.
5. Respondents Leader Investment, Inc. and Harry Cavallaris are jointly and severally liable to and shall pay Claimant Donald Onofrey the amount of \$225.00 (two hundred twenty-five dollars), as reimbursement for the NASD non-refundable filing fee.
6. Respondents Leader Investment, Inc. and Harry Cavallaris are jointly and severally liable to and shall pay Claimant Donald Onofrey for statutory interest of 8% (eight percent). Interest began to accrue on the date of filing, April 19, 2001, and shall cease to accrue upon payment of the amounts awarded in numbers 2-6 above and the total interest already due on the date of payment.
7. Any and all relief not specifically addressed herein, punitive damages, is denied.

Forum Fees and Assessments

The panel has the authority to assess forum fees for each hearing session conducted. A hearing session is any meeting between the parties and the arbitrators, including a pre-

hearing conference with the arbitrators, that lasts four (4) hours or less. Fees associated with these proceedings are:

One (1) Pre-hearing session with Panel x \$750.00 = \$ 750.00
Pre-hearing conference: November 14, 2001 1 session

Two (2) Hearing sessions x \$750.00 = \$1,500.00
Hearing Dates: February 20, 2002 2 sessions

Total Forum Fees = \$2,250.00


