Statement of Claim filed on or about April 30, 2001. Respondents filed a response on or about July 27, 2001.

ISSUES CONSIDERED AND DECIDED

Pursuant to stipulation of the parties, Claimants agreed to withdraw and dismiss all claims in the above-entitled case against all Respondents with prejudice.

Claimants further stipulated and agreed to the Arbitrator recommending expungement of all reference to the above-captioned arbitration from all registration records of Respondent ALLEN M. GREEN maintained by the NASD Central Registration Depository ("CRD"), with the understanding that, pursuant to NASD Notice to Members 99-09, Respondents must obtain confirmation from a court of competent jurisdiction before the CRD will execute the expungement directive.

AWARD

Pursuant to stipulation of the parties, but without making any findings of fact or conclusions of law, the undersigned Arbitrator orders that all claims having been withdrawn, the same are hereby dismissed with prejudice and without costs, except as specified hereinafter. Pursuant to stipulation of the parties, the Arbitrator recommends the expungement of any and all references to the above captioned arbitration from Respondent ALLEN M. GREEN's registration records maintained by the CRD, with the understanding that pursuant to NASD Notice to Members 99-09, Respondent Green must obtain confirmation from a court of competent jurisdiction before the CRD will execute the expungement directive.


