AWARD 01-04439: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Respondent Alan Bergman is liable and shall pay to the claimant \$8,641.00. 2) Respondent Alan Bergman is liable and shall pay to the claimant interest at the rate of 3.5% per annum from September 29, 2000 to October 28, 2002. 3) All requests for attorney fees are denied. 4) All other relief requests are denied. 5) The \$750.00 filing fee previously deposited with NASD Dispute Resolution by the claimant, shall be retained by NASD Dispute Resolution. 6) Respondent Alan Bergman is liable and shall pay claimant \$375.00 as reimbursement of one-half of the filing fee.

AWARD 01-04848: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Respondent Edward Monahan is liable and shall pay to the claimant \$36,955.00. 2) Respondent Edward Monahan is liable and shall pay to the claimant interest at the rate of 3.5% from October 4, 2000 to October 28, 2002. 3) All requests for attorney fees are denied. 4) All other relief requests are denied. 5) The \$1,450.00 filing fee previously deposited with NASD Dispute Resolution by the claimant, shall be retained by NASD Dispute Resolution. 6) Respondent Edward Monahan is liable and shall pay claimant \$725.00 as reimbursement of one-half of the filing fee.

AWARD 01-04854: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Respondent John Paul Schrader is liable and shall pay to the claimant \$18,147.00. 2) Respondent John Paul Schrader is liable and shall pay to the claimant interest at the rate of 3.5% per annum from September 27, 2000 to October 28, 2002. 3) All requests for attorney fees are denied. 4) All other relief requests are denied. 5) The \$1,050.00 filing fee previously deposited with NASD Dispute Resolution by the claimant, shall be retained by NASD Dispute Resolution. 6) Respondent John Paul Schrader is liable and shall pay claimant \$525.00 as reimbursement of one-half of the filing fee.

OTHER ISSUES: Respondents' Motion to Consolidate Claimant's claims was granted by the arbitrator prior to rendering a decision in the above-referenced cases.


