CASE INFORMATION

Statement of Claim filed on or about: January 6, 2003.

Claimants signed the Uniform Submission Agreement: October 14, 2002.

Statement of Answer filed by Respondent on or about: March 31, 2003.

Respondent signed the Uniform Submission Agreement: March 31, 2003.

CASE SUMMARY

Claimants asserted the following causes of action: churning; violation of industry rules; violation of Section 517.301 of the Florida Statutes; breach of contract; breach of fiduciary duty; common law fraud; negligence; and, negligent hiring, supervision and retention. The causes of action relate to the purchase and sale of shares of QLT Prodo Therapeutics and other unspecified securities products in Claimants' account.

Unless specifically admitted in its Answer, Respondent denied the allegations made in the Statement of Claim and asserted various defenses.

RELIEF REQUESTED

Claimants requested compensatory damages in the amount of \$800,000.00, plus interest at the legal rate from the date of purchase, or reasonable market return, rescission, attorneys' fees to be determined by a court of competent jurisdiction, punitive damages, costs and any other relief deemed just and proper.

Respondent requested that the Statement of Claim be denied in its entirety, plus attorney's fees.

OTHER ISSUES CONSIDERED AND DECIDED

During the evidentiary hearing on December 2, 2003, Claimants notified the Panel that the claim of churning was voluntarily withdrawn.

The parties have agreed that the Award in this matter may be executed in counterpart copies.

AWARD

After considering the pleadings, the testimony and evidence presented at the hearing, the Panel has decided in full and final resolution of the issues submitted for determination as follows:

Respondent is liable on the claims of negligence and negligent supervision and as such, shall pay to Claimants compensatory damages in the amount of \$42,493.44, plus interest at the Florida statutory rate from February 1, 2003 to the date of payment of the Award.

Claimants' and Respondent's respective requests for attorneys' fees are denied.

Any and all claims for relief not specifically addressed herein, including Claimants' request for punitive damages and claim for relief pursuant to Section 517.301 of the Florida Statutes, are denied.

FEES

Pursuant to the NASD Code of Arbitration Procedure (the "Code"), the following fees are assessed:




