NATURE OF DISPUTE: Customers v. Member and Associated Person

CASE SUMMARY: Claimants alleged that Respondents omitted material facts in connection with the offer and sale of WorldCom stock. Claimants alleged that Respondents violated Section 17(a) of the Securities Act of 1933, Chapter 517.301 of the Florida Securities and Investor Protection Act, and NASD Rule 2210(d)(1). Claimants further alleged that Respondents breached their fiduciary duty and that Citigroup Global Markets, Inc. is liable under the doctrine of respondeat superior.

OTHER ISSUES: On June 16, 2003, Claimants filed an Amended Statement of Claim.


