**CASE SUMMARY:** Claimant alleged that Respondents omitted material facts in connection with the offer and sale of WorldCom stock. Claimant alleged that Respondents violated Section 17(a) of the Securities Act of 1933, Chapter 517.301 of the Florida Securities and Investor Protection Act, and NASD Rule 2210(d)(1). Claimant further alleged that Respondents breached their fiduciary duty and that Citigroup Global Markets, Inc. is liable under the doctrine of respondeat superior.

**OTHER ISSUES:** On June 16, 2003, Claimant filed an Amended Statement of Claim.

**ARBITRATOR'S REPORT:**

Attorney's fees entitlement is awarded in favor of Claimant and against Citigroup Global Markets, Inc. f/k/a Salomon Smith Barney, Inc. in an amount to be determined by a court of competent jurisdiction in the circuit courts of Florida.

No liability is found against Jack B. Grubman as it relates to his personal involvement in this matter and its impact upon Claimant.

AWARD: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Respondent Citigroup Global Markets, Inc., f/k/a Salomon Smith Barney, Inc. is liable for and shall pay to the Claimant \$4,414.72. 2) Respondent Citigroup Global Markets, Inc. f/k/a Salomon Smith Barney, Inc. is liable for and shall pay to the Claimant interest at the rate of six percent (6%) per annum from 7/12/99 until the award is paid in full. 3) Respondent Citigroup Global Markets, Inc. f/k/a Salomon Smith Barney, Inc. is liable for and shall pay to the Claimant attorney fees in an amount to be determined by a court of competent jurisdiction in the circuit courts of Florida. 4) All requests for punitive damages are denied. 5) All other relief requests are denied. 6) NASD Dispute Resolution shall retain the \$175.00 filing fee that the Claimant deposited previously. 7) Respondent Citigroup Global Markets, Inc. f/k/a Salomon Smith Barney, Inc. is liable for and shall pay to the Claimant \$175.00 as reimbursement of the filing fee.


