CASE SUMMARY

Claimant alleged breach of fiduciary duty, misrepresentations and omissions, negligence, violations of Nevada Revised Statutes Sections 90.570, 90.660, 598.02 Et Seq., 41.1395, and liability under the theories of control person liability, respondeat superior, and agency. Claimant's allegations involved mutual funds, including MSDW American Opp. Fund, Van Kampen Emerging Growth, Van Kampen Equity Trust (Technology), and Van Kampen Select Growth.

Respondents denied the allegations of wrongdoing set forth in Claimant's Statement of Claim.

RELIEF REQUESTED

Claimant requested \$150,000.00 in compensatory damages, unspecified punitive and exemplary damages, unspecified consequential damages, disgorgement and restitution of all earnings, profit, compensation and benefits received by Respondents, treble damages, pre- and post-judgment interest, costs, and attorney's fees.

Respondents requested dismissal of the Claimant's Statement of Claim in its entirety, expungement of this arbitration proceeding from Pasquale Scaramuzzini, Jr.'s CRD records, costs, and attorney's fees.

OTHER ISSUES CONSIDERED AND DECIDED

Respondent Pasquale Scaramuzzini, Jr. did not file with NASD Dispute Resolution a properly executed submission agreement, but he is required to submit to arbitration pursuant to the NASD Code of Arbitration Procedure, and, having answered the claim and appeared and testified at the hearing, he is bound by the determination of the Panel on all issues submitted.

The parties agreed that the Award in this matter may be executed in counterpart copies or that a handwritten, signed Award may be entered.

AWARD

After considering the pleadings, testimony, and evidence presented at the hearing, the Panel decided in full and final resolution of the issues submitted for determination as follows:

- 1) Respondent Pasquale Scaramuzzini, Jr. is liable to and shall pay Claimant Nancy Pietrangelo, IRA the sum of \$37,486.02 in compensatory damages.
- 2) Respondent Prudential Securities, Inc. is liable to and shall pay Claimant Nancy Pietrangelo, IRA the sum of \$37,486.02 in compensatory damages.
- 3) Claimant's request for treble and punitive damages is denied.
- 4) The parties shall bear their respective costs, including attorney's fees.
- 5) All other relief requested and not expressly granted is denied.

FEES

Pursuant to the Code, the following fees are assessed:

Filing Fees

NASD Dispute Resolution received or will collect the non-refundable filing fees for each claim as follows:

The Panel assessed a forum fee for each pre-hearing conference or hearing session conducted. A pre-hearing conference and hearing session is any meeting between the parties and the Chair or the parties and the Panel. The following fees are assessed:


