Motion to Amend Statement of Claim and Amended Statement of Claim were filed on September 28, 2004.

Aetna's Response and Objections to Claimants' Amended Statement of Claim was filed on October 25, 2004.

### **CASE SUMMARY**

Claimants asserted claims against Aetna/ING, Sklader and Jones for alleged breach of fiduciary duty, professional negligence, negligent misrepresentation, fraud and violations of Arizona's securities statutes in connection with Claimants' 457 Plan investments. Claimants also asserted claims against Aetna/ING and Sklader for alleged negligent supervision.

The parties stipulated as follows:

- Claimants are participants in a deferred compensation plan that the City of Mesa established for its employees pursuant to Section 457 of the Internal Revenue Code ("the 457 Plan").
- Respondent ING Life Insurance and Annuity Company ("ING") is, and at all times relevant to the Arbitration, was a provider selected by the City of Mesa for the 457 Plan.
- Jones is a registered representative of ING Financial Advisers, LLC and ING Life Insurance and Annuity Company. Jones served as one of several ING account representatives for the 457 plan group annuity contract purchased by the City of Mesa for its employees, specifically from July 1999 through July 2001.
- Sklader was a registered representative of ING Financial Advisers, LLC and ING Life Insurance and Annuity Company. Sklader was a registered principal, and he was Jones' supervisor.
- Claimants invested in a number of the variable annuity mutual fund subaccounts offered in the Mesa 457 Plan ING group annuity contract, including the Janus Aspen Growth Fund, the Janus Aspen Aggressive Fund, the Janus Aspen Worldwide Growth Fund, and the Fidelity VIP Growth Fund.

Respondents denied the allegations set forth in the Statements of Claim. Respondents also asserted a number of affirmative defenses.

#### **RELIEF REQUESTED**

Claimants requested an award of unspecified compensatory and punitive damages.

Respondents requested that the claims asserted against them be denied in their entirety and that they be awarded their costs and attorneys' fees.

#### **OTHER ISSUES CONSIDERED & DECIDED**

Respondent Keith William Jones did not file with the NASD Dispute Resolution a properly executed submission to arbitration but is required to submit to arbitration pursuant to Rule 10301 of the NASD Code of Arbitration Procedure (the "Code") and having answered the claim is bound by the determination of the arbitration panel on all issues submitted.

Claimants and Respondents through their respective counsel stipulated to the dismissal without prejudice of Jones on August 25, 2004 and Sklader on August 27, 2004.

By letter dated November 8, 2004, the parties were advised of the Arbitration Panel's decision as follows:

The arbitration panel conferred telephonically this morning regarding the claimants' motion for leave to amend their statement of claim in the above referenced case, and we unanimously decided to permit all of the claimants' proposed amendments except for the addition of a new claim for breach of contract (section F at paragraphs 109-112 at pages 38-39 of the proposed amended statement of claim).

Claimants and Aetna/ING have resolved their remaining disputes and stipulate, hereby agree and request that each and every claim that Claimants assert against Aetna/ING, Sklader and Jones be dismissed from the Arbitration with prejudice.

The parties have agreed that the Award in this matter may be executed in counterpart copies or that a handwritten, signed Award may be entered. In either case, the parties have agreed to receive conformed copies of the award while the original(s) remain on file with the NASD Dispute Resolution (the "NASD").

**AWARD**

After considering the pleadings and the stipulation of the parties, but without making any findings of fact or conclusions of law, the undersigned arbitrators have decided in full and final resolution of the issues submitted for determination and find as follows:

1. Each and every claim that Claimants assert against Aetna/ING, Respondent Charles A. Sklader and Respondent Keith William Jones in NASD Case Nos.: 03-05191, 03-5194, 03-5195, 03-5196, 03-5240, 03-5519, and 03-5749 (Consolidated) is hereby dismissed with prejudice. This dismissal is binding on the Claimants and their respective marital communities who have an interest in the claims.
2. The Panel recommends the expungement of all information concerning Claimants' customer disputes with Aetna Financial Services, Inc.; Aetna Life Insurance and Annuity Co.; ING Financial Advisors, LLC, a/k/a Aetna Investment Services, Inc., a/k/a Aetna Investment Services, LLC, a/k/a Aetna Financial Advisors, LLC, Charles Andrew Sklader (CRD No. 2024954) and Respondent Keith William Jones (CRD No. 2956895), including but not limited to each and every allegation Claimants asserted against the aforementioned entities, Sklader or Jones in NASD Case Nos.: 03-05191, 03-5194, 03-5195, 03-5196, 03-5240, 03-5519, and 03-5749 (Consolidated), from Respondent Charles A. Sklader's and Respondent Keith William Jones's registration records maintained by the NASD Central Registration Depository ("CRD"), with the understanding that pursuant to NASD Notices to Members 99-09 and 99-54, Respondents Charles A. Sklader and Keith William Jones must obtain confirmation from a court of competent jurisdiction before the CRD will execute the expungement directive.

3. That to the extent not specifically awarded or otherwise provided for above, all other claims and requests for relief by any party hereto are denied with prejudice.
4. Other than the Forum Fees noted below, the parties shall each bear all other costs and expenses incurred by them in connection with this proceeding, including but not limited to attorneys fees, not specifically awarded or otherwise provided for above.




