REPRESENTATION OF PARTIES

John A. Tumpich and Phyllis Tumpich ("Claimants") were represented by John O'Donnell, Esq., Hiskes, Diller, O'Donnells, Marovich & Lapp, Ltd., Orland Park, Illinois.

H&R Block Financial Advisors, Inc. f/k/a Olde Discount Corporations ("H&R Block") and Robert Michael Widman, Jr. ("Widman"), hereinafter collectively referred to as "Respondents", were jointly represented by Lisa S. Flides, Esq., H&R Block Financial Advisors, Inc. f/k/a Olde Discount Corporation, Detroit, Michigan.

CASE INFORMATION

The Statement of Claim was filed on or about January 28, 2004. The Submission Agreement of Claimants was signed on or about January 26, 2004.

The Statement of Answer was jointly filed by Respondents on or about March 23, 2004. The Submission Agreement of Respondent H&R Block was signed on or about February 6, 2004. The Submission Agreement of Respondent Widman was signed on or about April 5, 2004.

CASE SUMMARY

Claimants alleged that Respondents erroneously entered an order to sell 320 shares of Walgreen stock out of their brokerage account.

Respondents denied the allegations of the Statement of Claim, alleging that Claimant placed the order as entered.

RELIEF REQUESTED

Claimant requested entry of an award for compensatory damages in the amount of \$4,151.50 and attorneys fees of \$1,000.00.

Respondents requested that the Panel enter an award in their favor and against claimants, as well as expunging the CRD record of representative Robert Widman.

OTHER ISSUES CONSIDERED & DECIDED

By letter dated August 5, 2004, Claimants advised that the matter was settled with Respondents.

The parties have agreed that the Stipulated Award in this matter may be executed in counterpart copies. The parties have agreed to receive conformed copies of the award while the originals remain on file with the NASD Dispute Resolution (the "NASD").

AWARD

After considering the parties submissions and representations, but without making any findings of fact or conclusions of law, the undersigned arbitrator orders as follows:

1. The matter is settled (subject to any conditions of a settlement agreement) between the remaining parties;
2. The undersigned arbitrator hereby orders that all information regarding this arbitration case be expunged from the record of Robert Widman (CRD # 2572573) in the Central Registration Depository ("CRD") of the National Association of Securities Dealers, Inc.;
3. The parties shall bear their own costs, subject to any settlement agreement, except for those specifically included herein; and
4. Any relief not stated as part of this award or part of any settlement agreement is denied.

FEES

NASD Dispute Resolution will retain or collect the non-refundable filing fees for each claim:

In this matter, the member firm(s) is H&R Block Financial Advisors, Inc. f/k/a Olde Discount Corporation.
