Public Customer v. Member Firm and Associated Person

Respondents Prudential Securities, Inc., n/k/a Prudential Equity Group, LLC, ("Prudential") and Frank Gonzalez-Soldevilla ("Gonzalez-Soldevilla") were represented by David A. Picon, Esq. and John R. Braatz, Esq., of Proskauer Rose, L.L.P., located in New York, New York.

CASE SUMMARY

Claimant alleged that Respondents had recommended unsuitable and speculative securities for her account by purchasing technology stocks and other high-risk investments. Claimant further claimed that Respondents failed to properly diversify Claimant's portfolio. Based upon these allegations, Claimant asserted causes of action for breach of fiduciary duty; misrepresentation; unsuitability; failure to supervise; negligence and *Respondeat Superior*.

Respondents in their Statement of Answer set forth that Claimant approved, authorized and ratified the acts complained of, that Claimant's losses were a result of her own conduct and Claimant's claim is barred by the doctrines of contributory negligence and/or comparative negligence, that Claimant did not rely to her detriment on any action or inaction of Respondents and that Claimant's claims are barred in whole or in part by the doctrines of estoppel, laches, limitations, and applicable eligibility rules. Respondents in their Motion to Dismiss, further argued that the Code of Arbitration Procedure empowers arbitrators to grant pre-hearing motions to dismiss, set forth that Claimant has no breach of fiduciary duty claim as a matter of law and requested an Order Expunging the Claims of Claimant from the NASD Central Registration Depository Records of Respondent Gonzalez-Soldevilla.

RELIEF REQUESTED

Claimant Audrey Stein Goldings requested:

Compensatory Damages	\$ 659,000.00
Punitive Damages	\$ 141,000.00

Other Monetary/Non-Monetary Relief if any:	Unspecified Amount

Respondents Prudential Securities, Inc., n/k/a Prudential Equity Group, LLC and Frank Gonzalez-Soldevilla requested that the Panel:

1. Dismiss the Statement of Claim in its entirety;
2. Award Prudential the costs and expenses of this arbitration;
3. Enter an Order expunging this matter from the NASD Central Registration Depository records of Gonzalez-Soldevilla; and
4. Award Prudential such other and further relief as is just and proper.

OTHER ISSUES CONSIDERED AND DECIDED

A telephonic hearing was held beginning at 10:00 a.m. on Wednesday, September 7, 2005. Present at the hearing were: Thomas Reavely and Nicholas Cooper, representing Claimant, and John R. Braatz and David Picon, representing Respondents. Also present at the hearing was Mark E. Nowicki, Senior Attorney, NASD Dispute Resolution. Respondents, acting by and through counsel, John R. Braatz and David Picon, presented arguments in support of their

Motion to Dismiss the Statement of Claim. Claimant, acting by and through her counsel, Thomas Reavely and Nicholas Cooper, argued against granting of the Motion to Dismiss. At the conclusion of the hearing, the panel held the hearing open until 5:00 p.m. on September 14, 2005, for the submission of such additional evidence in the form of letter briefs or affidavits as the Respondents or Claimant may elect to submit.

On or about, October 6, 2005, Respondent Francisco Gonzalez-Soldevilla filed a Motion for Expungement. No response to the Motion was filed. After review of the Motion and further deliberation, the Panel has determined that the Motion is granted and the previous Award entered in this matter is hereby amended.

AWARD

After considering the pleadings, the arguments presented at the pre-hearing, and the post-hearing submissions, the Panel has decided in full and final resolution of the issues submitted for determination as follows:

1. The arbitrators find that they have authority to dismiss matters before them pursuant to the NASD Code of Arbitration;
2. The evidence submitted by Claimant by sworn affidavit, when assumed to be true, fails to set out the basis for a claim against Respondents;
3. The Statement of Claim of Claimant is dismissed in its entirety without any finding of fault or liability on the part of Prudential Securities, Inc. and Frank Gonzalez-Soldevilla;
4. The Panel recommends the expungement of all reference to the above captioned arbitration from Respondent Frank Gonzalez-Soldevilla's registration records maintained by the Central Registration Depository ("CRD"), with the understanding that pursuant to NASD Notice to Members 04-16, Respondent Frank Gonzalez-Soldevilla must obtain confirmation from a court of competent jurisdiction before the CRD will execute the expungement directive. Unless specifically waived in writing by the NASD, parties seeking judicial confirmation of an arbitration award containing expungement relief must name NASD as an additional party and serve NASD with all appropriate documents. Pursuant to Rule 2130, the arbitration panel has made the following affirmative findings of fact: The claim, allegation, or information is factually impossible or clearly erroneous;
5. Each party shall bear their respective costs, including attorney's fees; and,
6. Any and all relief not specifically addressed herein is dismissed with prejudice.

FEES

Pursuant to the Code, the following fees are assessed:

NASD Dispute Resolution will retain or collect the non-refundable filing fees for each claim:

Accordingly, Prudential Securities, Inc., n/k/a Prudential Equity Group, LLC, is a party and the following Member Fees are assessed:




