CASE SUMMARY: Claimant alleged that Respondents are liable under Business Corporation Law Section 630(a) for an arbitration award in connection with wages owed to her for services performed pursuant to a Financial Terms of Employment Agreement entered into between International Securities Corporation and herself.

AWARD: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Respondents Isaac Vidomlanski and Menachem Cohen are jointly and severally liable and shall pay to the Claimant \$16,025.72. 2) All requests for attorney fees are denied. 3) All other relief requests are denied. 4) Respondents Isaac Vidomlanski and Menachem Cohen are jointly and severally liable and shall pay to the Claimant interest at the June 2004 broker's call rate from June 1, 2004 until the date of award payment. 5) NASD Dispute Resolution shall retain the \$425.00 filing fee that the Claimant deposited previously. 6) Respondents are jointly and severally liable and shall pay to the Claimant \$212.50 as reimbursement of one-half of the filing fee.

7) Telephonic conferences were held, October 4, 2004, October 21, 2004 and November 11, 2004. The forum fees for these conference calls are \$900.00. The forum fees are assessed as follows: Claimant is liable and shall pay to NASD Dispute Resolution forum fees in the amount of \$450.00; Respondents are jointly and severally liable and shall pay to NASD Dispute Resolution forum fees in the amount of \$450.00.

OTHER ISSUES: Pursuant to the By-Laws of NASD Dispute Resolution, the arbitrator determined that respondent Zvi Amit was served notice of the Statement of Claim and Notification of Arbitrator by regular mail, and Overdue Notice by certified mail, and is therefore bound by the arbitrator's ruling and determination.




