AWARD: The undersigned arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows: 1) Respondent is liable and shall pay to the claimant \$11,666.60. 2) Respondent is liable and is directed not to solicit any prior account or contacts from his employment with Claimant for one (1) year from the date of resignation. 3) Respondent is liable and directed to return any original records properly belonging to Claimant and to certify that he has purged or destroyed any computerized, duplicated or copies of records which he may have caused to be removed from the premises of Claimant. 4) All other relief requests are denied. 5) NASD Dispute Resolution shall retain the \$1,050.00 filing fee that the claimant deposited previously.

OTHER FEES: Pursuant to Rule 10333 of the Code, Claimant has paid to NASD Dispute Resolution the \$425.00 Member Surcharge previously invoiced.


