CASE INFORMATION

Statement of Claim filed on or about: January 18, 2005.

Claimant signed the Uniform Submission Agreement: January 19, 2005.

Statement of Answer filed by Respondent on or about: March 17, 2005.

Respondent signed the Uniform Submission Agreement: March 16, 2005.

CASE SUMMARY

Claimant asserted the following causes of action: failure to adhere to terms of arbitration award and non- payment of employment compensation.

Unless specifically admitted in its Answer, Respondent denied the allegations made in the Statement of Claim and asserted various affirmative defenses.

RELIEF REQUESTED

Claimant requested compensatory damages in the amount of \$889,300.00 in a lump sum payment, punitive damages, attorneys' fees and costs.

Respondent requested that Claimant's claim be dismissed in its entirety.

OTHER ISSUES CONSIDERED AND DECIDED

The parties have agreed that the Award in this matter may be executed in counterpart copies or that a handwritten, signed Award may be entered.

AWARD

After considering the pleadings, the testimony and evidence presented at the hearing, and the post-hearing submissions, the Panel has decided in full and final resolution of the issues submitted for determination as follows:

1. Respondent is liable for and shall pay to Claimant compensatory damages in the amount of \$395,000.00
2. Any and all relief not specifically addressed herein, including punitive damages, is denied.

FEES


