CASE INFORMATION

Statement of Claim filed on or about: April 19, 2006.

Claimant signed the Uniform Submission Agreement on: March 11, 2006.

Respondents' Motion to Dismiss the Statement of Claim filed on or about: June 26, 2006.

Claimant's Response to Respondents' Motion to Dismiss filed on or about: June 28, 2006.

Respondents' Reply in Further Support of Respondents' Motion to Dismiss the Statement of Claim filed on or about: November 24, 2006.

CASE SUMMARY

Claimant asserted the following causes of action: 1) breach of contract; 2) common law negligence; 3) fraud; 4) misrepresentation; 5) breach of fiduciary duty; and 6) failure to supervise. The causes of action relate to Claimant's stock investments in, including but not limited to, AOL, Millennium Pharmaceuticals and Genome Sciences, Inc.

RELIEF REQUESTED

Claimant requested: 1) compensatory damages in the amount of \$750,000.00; 2) interest; 3) costs; 4) punitive damages; and, 5) other relief as deemed just.

Respondents requested that the claims be dismissed

OTHER ISSUES CONSIDERED AND DECIDED

On or about December 4, 2006, the Panel granted Respondents' Motion to Dismiss the Statement of Claim.

The parties have agreed that the Award in this matter may be executed in counterpart copies.

AWARD

After considering the pleadings and oral argument of the parties on the Motion to Dismiss heard on November 29, 2006, the Panel has decided in full and final resolution of the issues submitted for determination as follows:

Respondent's Motion to Dismiss is granted pursuant to NASD Rule 10304 (c) (1) as the Statement of Claim was filed more than six (6) years after the occurrence or event that gave rise to the dispute. Any and all claims, not specifically addressed herein, including Claimant's claim for punitive damages, are dismissed with prejudice.

FEES

There were no adjournment fees assessed during the proceedings.

Three-Day Cancellation Fees

Fees apply when a hearing on the merits is postponed or settled within three business days before the start of a scheduled hearing session:

There were no three-day cancellation fees assessed during the proceedings.

Injunctive Relief Fees

Injunctive relief fees are assessed to each member or associated person who files for a temporary injunction in court. Parties in these cases are also assessed arbitrator travel expenses and costs when an arbitrator is required to travel outside his or her hearing location and additional arbitrator honoraria for the hearing for permanent injunction. These fees, except the injunctive relief surcharge, are assessed equally against each party unless otherwise directed by the panel.

There were no injunctive relief fees assessed during these proceedings.


