NET CAPITAL RULE AMENDMENTS AND INTERPRETATIONS:

The Interpretation Handbook has been revised to reflect the SEC's amendments of the Net Capital Rule in November 1992¹, (See Interpretation Memo 92-14). The alternative standard has been moved from paragraph (f) to paragraph (a), and related interpretations have been moved to appropriate paragraphs. Appendix E, which covers the implementation schedule of the new temporary minimum capital requirements, has been added to the rule. As a result of these rule changes, new interpretations have been issued and others have been amended to conform to the new rules.

Interpretations which were previously published in Interpretation Memos 85-11, 86-4, 86-9, 88-19, 90-11, 91-11 91-12, and 93-5, but not included in the handbook, have been added to the handbook.

Several new interpretations have been added and several existing interpretations have been revised for clarification, editorial and/or format changes.
